In 1995, I founded the Will County Children's Advocacy Center as a 501(c)(3) non-profit organization. The average dient is a 10 to 11-year-old girl, sexually abused by someone she knows and trusts. Their operations are funded through public and private grants, individual and corporate donations, and money raised at MEN WHO COOK – their only fundraiser.



When children make an outcry of abuse, the trained and compassionate forensic interviewers at the Will County Children's Advocacy Center obtain an accurate statement through a victim sensitive interview in their neutral, non-suggestive, and child-friendly environment. Before the Will County Children's Advocacy Center, children who suffered sexual abuse were required to make multiple statements to numerous parties, including law enforcement, child welfare workers and medical professionals, thereby increasing their trauma and enabling predators to exploit minor differences in their statements. Additionally, the Will County Children's Advocacy Center provides trauma-focused advocacy and mental health/therapy services, to enable the healing to begin.

As a MEN WHO COOK sponsor, you will:

- Help law enforcement take dangerous child predators off our streets
- Increase your visibility to an engaged group of community leaders & attendees

MEN WHO COOK features men from throughout the community who whip up their favorite dishes and offer bite-size samples to the guests – in a friendly and spirited competition. Last year, over 1,200 attendees and many generous sponsors helped us raise over \$110,000.

MEN WHO COOK is a favorite of all ages, and it provides critical financial support for Will County Children's Advocacy Center's programs providing hope, healing, and justice for abused children.

The only agency of its kind in Will County, the Will County Children's Advocacy Center is a private, 501(c)(3) non-profit organization providing hope, healing and justice for children who are sexually abused, severely physically abused, or have witnessed a violent crime.

Multidisciplinary teams (MDTs) consisting of the referring police detective, a child protective service (DCFS) investigator, a Will County assistant state's attorney, and a Will County CAC forensic interviewer, victim advocate, and trauma therapist all work together on each case in our child- friendly facility to reduce trauma and identify resources, so that children and their families may begin the healing process.

Children who have been victimized, and receive services at the Will County Children's Advocacy Center, are less likely to:

- Abuse drugs or alcohol.
- Grow up to become victims of domestic violence.
- Become involved in criminal activity.
- Suffer from depression, anxiety disorders, or post-traumatic stress disorder.
- Develop suicidal ideation and self-harm.
